Description

The 3M™ 8512 and 8514 Welding Respirators provide lightweight, eff ective, comfortable and hygienic respiratory protection against dust particles, non-volatile liquid particles and metal fumes whilst resisting clogging for extended use against welding fumes.

The 3M[™] 8514 respirator additionally provides respiratory protection against Ozone as well as off ering relief from nuisance levels* of organic vapours.

- Flame retardant, anti-clog, outer surface minimises the detrimental effects associated with welding splatter.
- The carbon layer in 3M[™] 8514 respirators provides protection against Ozone gas (10x Exposure Standard (ES)) and nuisance levels of organic vapours (below ES).

Maximum mass of products = 18g



Standards

These products meet the requirements of Australian / New Zealand Standard AS/NZS 1716:2003 for Respiratory protective devices. They should be used to protect the wearer from solid and nonvolatile liquid particles only.

Particulate Filter Respirators are classified by filtering efficiency and maximum total inward leakage performance (P1 & P2), also by inhalation resistance.

P1 filters are intended for use against mechanically generated particulates such as those generated from sanding, grinding, drilling, sweeping etc.

P2 filters are intended for use against both mechanically and thermally generated particulates e.g. welding, brazing etc. P2 fi Iters may also help reduce breathing in pathogenic biological airborne particulates such as influenza virus.

Approvals

These respirators have been produced to comply with the requirements of the Australian /New Zealand Standard AS/ NZS 1716:2003 under an agreed production certification scheme operated during manufacture in accordance with the SAI Global StandardsMark programme.

Applications

These respirators are suitable for use in concentrations of solid and non-volatile liquid particles up to the following limits:

Storage and Transportation

The 3M[™] 8512 and 8514 Welding Respirators have a shelf life of 3 years. End of shelf life is marked on the product packaging.

Before initial use, always check that the product is within the stated shelf life (use by date). Product should be stored in clean, dry conditions within the temperature range: – 20°C to + 25°C with a maximum relative humidity of <80%. When storing or transporting this product use original packaging provided.

Disposal

Contaminated products should be disposed as hazardous waste in accordance with local regulations.

Cleaning

The 3M[™] 8512 and 8514 Welding Respirators are designed for single shift use only.

DO NOT immerse product in water, detergent, cleaning fluids etc.

It is recommended that wearers be fit tested in accordance with AS/NZS 1715:2009 Standard. For information regarding fit testing procedures, please contact 3M.


Fitting Instructions

Must be followed each time the respirator is worn. Before fitting device, ensure hands are clean.

See Figure 1.

- Cup respirator in one hand with nosepiece at fi ngertips, allow headbands to hang freely below hand.
- 2. Hold respirator under chin, with nosepiece up.
- 3. Locate the upper strap across the crown of the head and the lower strap below the ears.
- 4. Straps must not be twisted.
- Using both hands, mould noseclip to the shape of the nose to ensure a close fit and good seal. Pinching the noseclip using only one hand may result in less effective respirator performance.
- The seal of the respirator on the face should be fit-checked before entering the workplace.

Fit Check

- Cover the front of the respirator with both hands being careful not to disturb the fit of the respirator.
- (a) UNVALVED respirator EXHALE sharply;
 (b) VALVED respirator INHALE sharply.
- If air leaks around the nose, re-adjust the nose clip to eliminate leakage. Repeat the above fit check.
- If air leaks at the respirator edges, work the straps back along the sides of the head to eliminate leakage. Repeat the above fit check.

If you CANNOT achieve a proper fit DO NOT enter the hazardous area. See your supervisor.

It is recommended that wearers be fit tested in accordance with AS/NZS 1715 Standard. For information regarding fit testing procedures, please contact 3M.

- In case of intended use in explosive atmospheres, contact 3M.
